Sub.- Village Panchayat Elections-Expenditure by Contesting Candidates.

Whereas, the Goa State Election Commission by its Notification No. 6-2-2010-Sec-5 dated 1st February, 2011 had prescribed a Code of Conduct for ensuring free, fair and peaceful elections to the Panchayats at all level and Municipal Councils and laid down limits of expenditure to be incurred by candidates in connection with the elections;

And whereas the State Election Commission is of the opinion that the said limits are required to be revised in view of increase in the prices;

Now, therefore, I, Shri R. K. Srivastava, IAS (Retd.), Commissioner, Goa State Election Commission, in exercise of the powers vested in me under Article 243 K and 243 ZA of the Constitution of India hereby described that the limits of expenditure that may be incurred by the candidates (either by himself or by his authorized agent or any other individual) in connection with the elections, shall be as given below;

In case of every candidate contesting elections to the Village Panchayats	...	Rs. 40,000/-

The contesting candidates should maintain the detailed account of daily expenditure and submit it to the concerned Returning Officer alongwith the Abstract in the prescribed format within a period of one month from the date of election.
